## **REPORT OF THE INDEPENDENT AUDITORS**

We have audited the financial statements of the Federación Nacional de Futbol de Guatemala -FEDEFUT- comprising the general balance as of December 31, 2021 and the corresponding statement of results, changes in the patrimony and cash flow for the year ending on that date, as well as a summary of the significant accounting policies and other explanatory notes. We have emitted our report on June 17, 2022, expressing our unqualified opinion.
